Public Notice Draft Nathan-Salisbury-Moorooka neighbourhood plan

At its meeting on 6 December 2022 Brisbane City Council proposed a major amendment to *Brisbane City Plan 2014* and changes to planning scheme policies to introduce the new Nathan-Salisbury-Moorooka neighbourhood plan (proposed amendment). The proposed amendment applies to parts of the suburbs of Nathan, Salisbury and Moorooka.

The purpose and general effect of the proposed amendment is to:

- introduce the Nathan-Salisbury-Moorooka neighbourhood plan code;
- amend the table of assessment for certain types of development;
- amend the strategic framework, zones and overlays to respond to finer grained planning for the area;
- undertake consequential amendments to the Holland Park-Tarragindi and Moorooka-Stephens district neighbourhood plans; and
- amend the Infrastructure design and Structure planning planning scheme policies to include references to the Nathan-Salisbury-Moorooka neighbourhood plan.

Public Notice Qualified state interest amendment – Local heritage

As its meeting on 6 September 2022, Brisbane City Council proposed a Qualified state interest amendment – Local heritage to *Brisbane City Plan 2014* to ensure our city's heritage places and areas are protected into the future

The purpose and general effect of the proposed amendment is to:

- include new local heritage places and area adjoining heritage properties on the Heritage overlay;
- add a local heritage area through a new Local heritage area sub-category to the Heritage overlay, to reflect the Moorooka War Workers' Housing Estate (former);
- remove the Traditional building character overlay to reflect properties being included in the Heritage overlay; and
- include zoning and Dwelling house character overlay changes to support the new local heritage places and local heritage area changes.
