## **Part 1                      Preliminary**

### **1            Short title**

This local law may be cited as the Queensland Tennis Centre Parking Area Local Law 2009.

### **2            Objects**

The objects of this local law are to –

- (a) create Traffic Areas collectively called the Queensland Tennis Centre Parking Area; and
- (b) regulate parking within the Queensland Tennis Centre Parking Area.

### **3            Definitions**

(1) In this local law:-

“**city**” means the area comprised in the City of Brisbane under the *City of Brisbane Act 1924*;

“**Council**” means the Brisbane City Council;

“**official traffic sign**” has the meaning given to it in the *Transport Operations (Road Use Management) Act 1995*;

“**park**” has the meaning given to it in the *Transport Operations (Road Use Management) Act 1995*;

“**road**” has the meaning given in the *Transport Operations (Road Use Management) Act 1995*;

“**traffic area**” has the meaning given to it in the *Transport Operations (Road Use Management) Act 1995*;

## **Part 2                      Queensland Tennis Centre Parking Areas**

### **4            Traffic Area**

The parts of the City the boundaries of which are defined by the black bordering indicated on the map in Schedule 1, and labelled 1, 2 and 3, are declared to be Traffic Areas.

### **5            Name of Traffic Area**

The Traffic Areas declared under section 4 are collectively called the Queensland Tennis Centre Parking Area.

### **6            Regulation of parking**


Parking in the Queensland Tennis Centre Parking Area is allowed only for the maximum time specified on the official traffic signs mentioned in section 7 at the days and times specified on those official traffic signs.

Infringement notice penalty – 0.5 penalty units.

### **7            Commencement of regulation of parking**

For the Queensland Tennis Centre Parking Areas, the regulation of parking commences on the day after Council installs official traffic signs indicating how parking is regulated on the road at every road entry to the Queensland Tennis Centre Parking Area.
