Draft Mt Gravatt Centre Suburban Renewal Precinct Plan**

At its meeting on 11 November 2025, Brisbane City Council proposed a tailored amendment to *Brisbane City Plan 2014* and changes to planning scheme policies to introduce the new Mt Gravatt Centre Suburban Renewal Precinct Plan and to make supporting and consequential amendments, including changes to the Mt Gravatt corridor and Holland Park—Tarragindi district neighbourhood plans and to include areas currently outside of these neighbourhood plan areas (proposed amendments). The proposed amendments apply to parts of the suburbs of Mt Gravatt, Mt Gravatt East, Upper Mt Gravatt, Holland Park and Holland Park West.

The purpose and general effect of the proposed amendment is to:

- amend the Mt Gravatt corridor neighbourhood plan code and extend these provisions to the broader plan area;
- amend the Strategic framework, zones, neighbourhood plan (including changes to precinct/sub-precinct boundaries in the Mt Gravatt corridor and Holland Park—Tarragindi district neighbourhood plans) and overlay maps to respond to finer grained planning for the area;
- undertake consequential amendments to the Holland Park—Tarragindi district neighbourhood plan; and
- amend the Infrastructure design and Structure planning planning scheme policies.
