You are required to provide details of the works that you plan to undertake.

The information provided on this form will assist Council staff in determining requirements that will ensure that the condition of the landfill is maintained in a manner that will minimise potential environmental and human health impacts. It will also assist in determining if the development is carried out in accordance with the City Plan and Queensland Integrated Planning Act 1997.

As part of the approval process, you will have obligations and environmental requirements to undertake as part of the proposed development. If required, a meeting to discuss the proposed development will be arranged between Council officers and representatives of your organisation.
