1.0 GENERAL

The specifications for the development (other than building work) should be based on the technical requirements of the *Reference Specifications for Civil Engineering Work* (Brisbane City Council, 2001). The modules contained in the document are listed below:

- S110 General Requirements
- S120 Quality
- S140 Earthworks
- S150 Roadworks
- S160 Drainage
- S170 Stonework
- S180 Unit Paving
- S190 Landscaping
- S200 Concrete Work
- S210 Masonry
- S220 Woodwork
- S230 Structural Steel
- S240 Coatings
- S300 Quarry Products
- S310 Supply of Dense Graded Asphalt
- S320 Laying of Asphalt
- S330 Sprayed Bituminous Surfacing
- S340 Supply of Stone Mastic Asphalt (under development)

The Reference Specifications define default provisions acceptable to Council for the typical situations and designs. The Developer may submit alternative provisions for approval of the Council's Delegate and should submit provisions for work beyond the scope of the Reference Specifications. Approval by Council Delegate of the specifications extends only to the technical requirement. The Developer is responsible for any contractual or other legal impacts of the specification provisions.

To facilitate the approval process, it is recommended that the Reference Specifications be adopted intact and their effect be modified, as necessary, by a job specification and/or annexure to the specifications and/or additional specifications and/or other modifying instrument. Only such modifying instruments then need to be submitted for approval.

The reference specification for General Requirements gives precedence to the job specification and any annexure to the specifications (in that order) over all the reference specifications.



2.0 HOW TO GET A COPY

The current edition of the Reference Specifications and Annexures are available for free download on the Brisbane City Council Website. To access these documents, follow these steps:
